Effective July 1st, 2025
Our Funds Availability Policy Will Be Changing as follows:

Funds we make available for withdrawal by checks that are not subject to same day availability will increase from \$225 to \$275.

Exception Holds for Large Deposits, New Accounts, Repeated Overdrafts, Reasonable Doubt for Collectability will increase from \$5,525 to \$6,725.



On May 1st & May 2nd, 2025, the office staff will be reduced to just two Member Services Representatives.

As such, services may be limited and wait times--especially for loan requests--may be longer than usual.

To assist, we kindly ask that you call the office at least one day in advance for all check withdrawals/cashier check requests.
