DIVIDENDS TAX STATEMENTS

Just a friendly reminder that your **December year end statements** serve as your statement of credit union dividends earned and interest paid for that year.

Form 1099-INT: Interest Income, you will receive a 1099-INT if your total dividends earned in 2025 are **at least \$10.00**.

Tax documents from 'Ewa FCU is typically mailed and available by January 31, 2026.



As an 'Ewa FCU member, you can save **20%** on Turbo Tax, whether you file yourself or have an expert file for you. Or save up to **\$25** on in-office tax prep services from H&R Block. You can save even more with early-season pricing when you file by February 28th.

BEWARE of TAX SCAMS



If you are contacted about a tax rebate or refund payment:

- **Never click on links from unexpected texts or emails.**
- **Keep in mind the IRS won't call, email or text to contact you for the first time.**
- **Check the status of a pending refund on the IRS website's "Where's My Refund" page.**
- **Email phishing@irs.gov to report unsolicited text or emails claiming to be the IRS.**

However, if you find that you have clicked on a link in one of those texts or messages and shared information, file a report at IdentityTheft.gov to get a customized recovery plan based on what information you shared.
